****Payment Standard Jurisdiction outside of Watertown, MA and the Boston-Cambridge-Quincy Metropolitan Area**
Although the Town of Watertown, MA, constitutes the WHA's principal area of jurisdiction, the WHA has jurisdiction to administer the HCV program throughout the Commonwealth of Massachusetts. As such, WHA's Payment Standards will be set at 100% of HUD's FMR by bedroom size (studio, 1, 2, 3, 4, etc.) for each community located within each HUD Metro FMR Area in which WHA administers vouchers.
